#### **About AFDW**



- AFDW is a direct reporting unit to Headquarters Air Force, reporting to the Chief of Staff of the Air Force.
- AFDW is responsible to organize, train, equip and provide forces for AEF deployment, provide ceremonial support, and conduct homeland operations as part of a Joint effort, within the NCR.
- AFDW exercises UCMJ authority over, and provides manpower, personnel, legal, chaplain, finance, logistics, and safety support for designated Air Force activities located within the NCR, selected Field Operating Agencies, and selected Air Force elements.

## FAR Subpart 26.202 Local Area Preference



When awarding emergency response contracts during the term of a major disaster or emergency declaration by the President of the United States under the authority...

#### 26.202-1 -- Local Area Set-aside.

The contracting officer may set-aside solicitations to allow only local firms within a specific geographic area to compete (see <u>6.208</u>).

- (a) The contracting officer, in consultation with the...
- (b) A major disaster or emergency area may span...
- (c) The contracting officer shall also determine...
