



## NONDISCLOSURE AGREEMENT PSI ACCESS – DoD CONTRACTOR WITH SE CERTIFICATION

United States Air Force safety reports and briefings contain privileged information. Privileged safety information is used solely for Department of Defense mishap prevention and may only be released or discussed within USAF safety channels, unless authorized by an appropriate official. Protecting privileged safety information is essential to maintaining the integrity of the process whereby mishap information is obtained and evaluated.

Privileged information includes:

- a. Findings, conclusions, causes, recommendations, analysis and the deliberative process of safety investigators or officials
- b. Any information obtained from a contractor who built, designed, or maintained equipment involved in a mishap, provided pursuant to a promise of confidentiality
- c. Statements or testimony given to safety investigators pursuant to a promise of confidentiality
- d. Computer generated videotape animations, simulations, or simulator reenactments that include the analysis of safety investigators
- e. Drafts indicating safety investigators' analysis or conclusions
- f. Photographs, films, and videotapes, which are staged, reconstructed, or simulated reenactments of possible or probable scenarios developed by or for safety investigators
- g. Diagrams and other exhibits which depict safety investigators' analysis

I am reviewing privileged safety information for a safety-related purpose, thereby assisting the USAF mishap prevention program. I understand that no other use is authorized. I shall not publicly release nor reproduce privileged information, or otherwise share it with anyone not granted access to the information by the USAF, including non-DoD or foreign military officials. My strict adherence to these limitations is essential to the continued success of USAF mishap investigations and accident prevention. Unauthorized use or disclosure of privileged safety information can prevent successful protection of it in court proceedings and could lead to adverse court decisions. I am expressly prohibited from providing any privileged safety investigation information to my general counsel's office, legal staff, or any personnel involved in litigation. I also understand that, as a DoD contractor, I am subject to punitive or adverse personnel action for willful or negligent violation of these restrictions.

I acknowledge receipt and understanding of the above, and I agree not to reveal privileged safety information unless authorized by USAF regulations or safety officials.
